August 2018 - Preliminary review reveals paucity of data


November 2018 – Project Incubator Initiated

# Systematic Review Methods

- Participatory Consensus Approach
- > Reviews included:
  - Peer reviewed journal articles
  - Commentaries
  - Published newsletters
  - Concept papers
  - White papers indexed in PubMed and Web of Science
- > Article must be published in English:
- Discussed ethical, legal, social and/or public policy considerations of partnerships between non profit patient advocacy organization and:
  - $\circ$  Researcher
  - Sponsor
  - Donor
- > Proposed research funding for a clinical trial (regardless of design)



# Literature Review Exclusion Criteria


 Discussion of strategies and practices related exclusively to corporate social responsibility
Financial conflicts of interest without addressing underlying ethical, legal or social considerations for nonprofit organizations



# **Overview of Results**

- Nonprofit organizations are a growing source of trial funding, but are not subject to the same oversight as industry, academia etc.
- Trust and transparency are critical when nonprofits are considering funding a trial and throughout its lifecycle and are best maintained when nonprofits select trials that:
  - undergo rigorous scientific and ethical evaluation
  - disclose conflicts of interests, real or perceived among all actors
  - regularly report trial progress, milestones, and results
  - develop an agreed-upon framework for openly sharing trial results
  - keep donors informed about the impact their support is having



# Remaining Knowledge Gaps

- Managing relationships when individuals fit into more than one stakeholder group i.e. donor and patient; researcher and sponsor
- > Is direct recruitment of patients involved with the nonprofit funder ethically acceptable?
- > Ethical issues surrounding nonprofits with a financial interest in the commercialization of a specific drug, sometimes otherwise called venture or entrepreneurial philanthropy



**Future Directions** 

Develop an evaluation framework to track progress on white paper recommendations

Conduct internal survey of CAC2 members to determine applicability and remaining gaps
